MEASURE of the Ministry of Economy of the Slovak Republic

No. 1/2019 of 19 August 2019

laying down the types of defence-related products for general transfer licence

Pursuant to §43(e) of Act No. 392/2011 Coll. on trading in defence-related products and on amendments to certain acts (hereinafter only referred to as the "Act"), the Ministry of Economy of the Slovak Republic has laid down as follows:

§1

The general transfer licence applies to the defence-related products specified in Annex 1 intended for demonstration and evaluation purposes, in Annex 2 intended for repair and maintenance purposes, and in Annex 3 intended for exhibition purposes.

§2

This measure transposes the legally binding acts of the European Union specified in Annex 4.

§3

This measure becomes effective on 15 September 2019.
