COM request regarding transparency

European Commission approached all Member States with the following request: "To enhance the transparency of the preparation and adoption process of the future programming documents, we would like to invite you to make publicly available all draft and official programming documents on the webpages of the relevant authorities." We suggest to share the draft Cooperation Programme text once it is available and later on its updated versions with the public.

UK - principle of non-participation

Interact Managing Authority had an email exchange regarding UK participation in the programming of Interact IV programme and the response was, that "in line with the 'principle of non-participation' included in the Withdrawal Agreement (Article 7(1)) agreed by EU27 Member States, persons representing the UK, or nominated or appointed by the UK, should no longer participate in meetings where the post-2020 period is discussed. Therefore, the UK should not be part of task forces/programming committees preparing the 2021-27 programmes." Please find the full email exchange as Annexe 2.




