Having regard to the EU regulations laying down provisions on the Structural Funds, in particular Regulation (EU) No 1303/2013 of the European Parliament and of the Council of 17 December 2013 laying down common provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development and the European Maritime and Fisheries Fund and laying down general provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund and the European Maritime and Fisheries Fund and repealing Council Regulation (EC) No 1083/2006, and Regulation (EU) No 1299/2013 of the European Parliament and of the Council of 17 December 2013 on specific provisions for the support from the European Regional Development Fund to the European territorial cooperation goal (furthermore referred to as ETC Regulation), as well as the INTERACT III 2014-2020 Cooperation Programme (CCI 2014TC16RFIR002), as approved by the INTERACT III Programming Committee on 19 December 2014 and with specific reference to Article 8 of the ETC Regulation, we agree to the following:
